On May 17, 1896, an outbreak of strong tornadoes struck northeast Kansas, killing many people and inflicting damage to numerous communities from Clay County to Brown. Using newspaper accounts, plat maps, and site visits, it is possible to reconstruct this event, showing the impact of an enormous supercell storm that produced a tornado more than two miles wide.

The Kansas Incident Support Program (ISP) is designed to aid incident commanders in the field via an Incident Support Team (IST) and/or emergency managers in the emergency operations center via an Emergency Operations Center (EOC) Support Team. Kansas ISP membership is comprised of public safety professionals from political subdivisions across the state. Members of the Kansas ISP represents expertise in their career fields and has completed position-specific training for the respective position(s) that they fill. This breakout will highlight concepts of the Incident Support Program, how to become a member, making requests for incident support program support, and the National Qualification System Position Task Book credentialing.

5.2: KDEM - Orion Damage Assessment Tool - Jonathan York, Repsonse & Recovery Bureau Director, KDEM, Heidi Hessler, CEO of Futurity IT, Colleen Bresnahan, Business Development, Futurity IT

Kansas Division of Emergency Management has procured the Orion Damage Assessment Tool through Futurity IT to assist counties and the state with public assistance and individual assistance damage assessments after an emergency or disaster occurs.

The Orion Damage Assessment Tool is used for gathering information for a damage assessment in areas impacted by an emergency or disaster, so that KDEM can determine whether the damages meet thresholds for federal disaster assistance under a major presidential disaster declaration. The Orion Damage Assessment Tool will allow local levels of government, eligible private non-profit organizations, and residents to submit storm damages at an address and give users the opportunity to add specialized information such as maintenance records for road infrastructure and photos of disaster damaged facilities. This breakout will highlight capabilities of the Orion Damage Assessment Tool prior to conducting regional trainings across the state with emergency management stakeholders.

SPEAKER BIOS



ANDY BAILEY

Andy Bailey has been a meteorologist with the National Weather Service (NWS) for more than 29 years and is the Warning Coordination Meteorologist (WCM) at the NWS office in Kansas City, MO. In this position he serves as the principle NWS liaison with the emergency management and media communities and is responsible for all of his office's public education and outreach activities in northwest and central Missouri and far eastern Kansas. Essentially his activities are aimed at making the office's forecast and warning programs more effective. He has been in the Kansas City area for 16 years. Prior to this position, he served at the NWS offices in Las Vegas, NV, Rapid City, SD and Des Moines, IA.



BRUCE CHLADNY

Bruce Chladny joined the KAC as Executive Director in August 2019. Prior to that, he worked for Kansas State University. During his tenure at K-State, his work focused on projects including facilitation, team building, and leadership. His latest position was at the K-State Research and Extension office in Wyandotte County. He has worked with governmental entities and non-profit organizations to cooperatively address issues affecting the KC Metropolitan area. Chladny holds a Master of Science in Agricultural Economics from the University of Missouri and a Bachelor of Science in Commercial Horticulture from Purdue University.

He joined the National Weather Service in Des Moines, Iowa in 1989.

A native of Dodge City, Mr. Hutton was selected as one of the first forecasters at the modernized weather office in Dodge City in early 1992. He was selected as the Warning Coordination Meteorologist at the Dodge City office in 1994, a position he has held since.

As the Warning Coordination Meteorologist, Mr. Hutton actively works with city, county and state officicals in promoting weather awareness and safety. He also gives numerous weather and climate presentations at crop and livestock producer meetings.



BRUCE JONES

Bruce Jones is a meteorologist with Midland Radio Corporation in Kansas City. Since seeing The Wizard of Oz at age five, he has been fascinated by tornadoes and Kansas weather, and spent more than thirty years on radio and TV stations in the heart of Tornado Alley, keeping people safe from severe weather. A tornado historian, he collects information about famous incidents and outbreaks. Bruce has advocated on behalf of the "Voice of the National Weather Service": NOAA Weather Radio for more than forty-five years...and has no intention of stopping.



CHARLES (CHUCK) MAGAHA

Chuck is currently the Director for Leavenworth County Emergency Management Homeland Security. He has held this position for the last 31 years. He has served 3 terms as President of KEMA. Chuck currently serves as the Homeland Security Chair of Kansas representing all 7 regions of the State of Kansas and Kansas State agencies. He is the State Division Supervisor of the Kansas City Division for the Kansas All Hazards Incident Management Teams in Johnson, Wyandotte and Leavenworth County. Chuck received the first president's award in 2015 from KEMA. Chuck is a member of the Kansas Division of Emergency Managements training cadre for various emergency management courses. He is the lead instructor in the State of Kansas to teach Debris Management throughout the state of Kansas. He is State and nationally trained certified instructor of the Incident Command Systems (ICS), which is delivered to emergency responders and many other agencies in the private sector. Chuck has been involved in law enforcement and has been a volunteer firefighter for Fairmount Township Fire Department in Basehor, Kansas for over 43 years. ANGEE MORGAN

A graduate of Fort Hays State University, Angee Morgan joined the Kansas Division of Emergency Management (KDEM) in December 1987. On November 1, 2016, she was promoted from the mitigation and planning branch director to deputy director of KDEM. Angee spent 11 years in the operations branch as the individual assistance officer and four years as senior planner before becoming deputy director. Angee began her state career in September 1981 with the Kansas Highway Patrol. Angee is a graduate of the 1997 Kansas Certified Public Manager Program and is a 2013 graduate of the Naval Postgraduate School Center for Homeland Defense and Security's Homeland Security Executive Leaders Program.

Chip is a Meteorologist at Kansas State University. He manages the Kansas Mesonet and provides climate services for the Office of the State Climatologist. In addition, he is a Lieutenant on his local fire department, wildland firefighter, and an Incident Meteorologist (IMET). He also specializes in Predictive Services for the Kansas Forest Service.



JILLIAN RODRIGUE

Jillian Rodrigue is an Emergency Manager with over 15 years of experience and is currently the Deputy Director of Douglas County Emergency Management. In this position, she is responsible for agency functions that include operations, community training and outreach, and volunteer management.

Growing up along the Louisiana coast provided Jillian with both personal and professional disaster experiences. She has extensive emergency management experience, including the Presidentially declared May 28, 2019 Lawrence / Linwood, Kansas EF-4 Tornado, Greensburg, KS Tornado (2007), major flooding (2007, 2017 & 2019), and major snowstorms (2009 & 2013).
